

\$15K Summer Cash Splash

TERMS & CONDITIONS

General

1. The '\$15K Summer Cash Splash' promotion will commence at 10am on Monday 8th December 2025 and run until approximately 10pm on Sunday 25th January 2026.
2. All financial Burleigh Sports Club members are eligible for the promotion.
3. Members will earn one (1) entry ticket during the promotional period with every \$10 play (turnover) on the gaming machines with their membership card inserted, or \$5 spend on food and beverage (where card services are available and members card is swiped) at Burleigh Sports Club.
4. Management may elect to offer bonus cash prizes based on members loyalty tier, offer bonus entries into the promotion, &/or bonus entry periods for nominated draw dates at their discretion.
5. Members will need to check-in for the promotion within two (2) hours before the draw start time by:
 - a. Swiping their membership card at the kiosk; or
 - b. Checking in via the promotion button on the Nexus Kiosk; or
 - c. Inserting their card in a gaming machine; or
 - d. Using their card at the point of sale when making a food or beverage purchase.
6. Members also need to validate their entries within forty-five (45) minutes before each draw to be eligible for the draw by:
 - a. Swiping their membership card at the kiosk; or
 - b. Inserting their card in a gaming machine; or
 - c. Using their card at the point of sale when making a food or beverage purchase.
7. The validation time of eligible entries may be changed by the promotional staff in the event of three (3) + redraws occurring, the promotional staff will notify patron of this occurrence and allow ample time for members to re-swipe their membership cards. It is the patron's responsibility to re-validate their entries.
8. All draws are conducted using the Nexus Draw application, no paper tickets will be issued.
9. All entry tickets will be deleted at the conclusion of the promotional period and will not be retained for any other promotion.
10. It is the responsibility of eligible members to position themselves within Burleigh Sports Club where they can hear the public-address announcements.
11. Members must present their membership card to the promotion host when claiming a prize. Additional proof of identity may be requested at the discretion of management.
12. Weekly preliminary draws will be held every Friday during the promotional period. A total of five (5) draws will take place each draw day, with one (1) draw every thirty (30) minutes from 6.30pm – 8.30pm on the below dates:
 1. Friday 12th December 2025
 2. Friday 19th December 2025
 3. Friday 26th December 2025
 4. Friday 2nd January 2026
 5. Friday 9th January 2026
 6. Friday 16th January 2026
 7. Friday 23rd January 2026 – Major Draw
13. Members selected from the Nexus Draw application will have two (2) minutes to claim their prize from the specified draw area. If the selected winner does not present themselves within the allocated timeframe, a redraw will take place until an eligible winner is found.
14. Each winner will select a total of four (4) cards from a gameboard of twenty-four (24) cards. Card breakdown as follows:
 - a. One (1) x \$10 Cash with a 'Rocket'
 - b. One (1) x \$20 Cash
 - c. One (1) x \$20 Cash with a 'Rocket'
 - d. Two (2) x \$25 Cash
 - e. Nine (9) x \$30 Cash
 - f. Two (2) x \$30 Cash with a 'Rocket'
 - g. Three (3) x \$40 Cash
 - h. One (1) x \$40 Cash with a 'Rocket'
 - i. One (1) x \$50 Cash
 - j. One (1) x \$100
 - k. One (1) x \$100 with a 'Rocket'
 - l. One (1) x \$200

15. Preliminary winners will receive the total of all four (4) cards chosen (base prize), plus any 'Large Sun/s' cash bonuses, and one (1) major draw entry.
16. Should a member find one (1) or more "Large Sun" symbols on the cards selected, they will receive one (1) of the following cash bonuses on top of their prize:
 - a. One (1) Large Sun - \$50
 - b. Two (2) Large Suns - \$100
 - c. Three (3) Large Suns - \$200
 - d. Four (4) Large Suns - \$800
17. The member will have finished their turn and the game will be over once they have selected four (4) cards without "Large Sun" symbols. The minimum cards selected will be four (4) and the maximum can be fourteen (14).
18. After each draw, all cards will be returned to the gameboard and shuffled ahead of the next draw.
19. Members can only win a maximum of two (2) weekly preliminary prizes each promotional draw day.

Major Draw

1. The major draw will take place on Friday 23rd January 2026 at approximately 9pm following the final preliminary draws.
2. A major draw register of the preliminary winner's names and badge numbers will be maintained throughout the promotion. Members will be allocated a major draw entry number based on the order in which they were drawn throughout the promotional period (1-24).
3. Three (3) finalists will be selected to pick a sun prop to stand behind. Once all suns have been selected the promotions host will direct the finalist to reveal their prizes.
4. All cash won during the preliminary weekly draws will be deducted from the guaranteed giveaway total (\$15,000), in which all remaining cash will be given away in the major draw to three (3) members.
5. The Major Draw prizes will consist of two (2) Runner Up prizes of \$250 cash each & any remaining cash in the \$15K prize pool which is estimated to be approximately \$6,300.
6. The major draw prize will be for all remaining cash up to the guaranteed \$15,000 prize pool or \$5,000 cash whichever is greater.
7. The maximum total promotional prize pool including preliminary draws is \$15,000.

Standard Conditions

4. Burleigh Sports Club accepts no responsibility for any error, omission, interruption, deletion, defect, delay in operation, system failure, theft or destruction and reserves the right to take appropriate action as required any such matters.
5. In the case of the intervention of any outside act, that hinders Burleigh Sports Club's ability to proceed with the promotion on the dates and in the manner described in these terms and conditions, including but not limited to
6. vandalism, power failures or natural disasters, management may in its absolute discretion take any action that may be available to cancel, terminate, modify or suspend the promotion.
