



# Members Swipe & Win

## TERMS & CONDITIONS

### Promotion Terms:

1. The 'Members Swipe & Win' promotion will commence at 10am on Thursday 2<sup>nd</sup> April 2026 and run until further notice.
2. All financial members of 'The Bears Group' of The Bears Group are eligible for the promotion.
3. Members will earn one (1) entry ticket during the promotional period each day when they swipe & touch at the kiosk at Burleigh Leagues Club or Burleigh Sports Club.
4. Members will earn entries into a separate draw barrel depending on the location entry.
5. Members who qualify for an entry at Burleigh Leagues Club will not earn an entry into the Burleigh Sports Club draws.
6. Members who qualify for an entry at Burleigh Sports Club will not earn an entry into the Burleigh Leagues Club draws.
7. Members can enter as many times as they like during the promotional period when they meet the entry criteria.
8. Management may elect to offer bonus cash prizes based on members' loyalty tier, offer bonus entries into the promotion, &/or bonus entry periods for nominated draw dates at their discretion.
9. Members will need to check-in for the monthly 'Members Swipe & Win' draws from two (2) hour before the commencement of the first draw by swiping their membership card at the kiosks at the venue they are occupying and where the draws are taking place at.
10. Members must validate their entries within two (2) hours of each draw, by swiping their card during a POS transaction, or inserting their card into a gaming machine while playing or checking in via the kiosk.
11. All draws are conducted using the Nexus Draw application; no paper tickets will be issued.
12. All entry tickets will be deleted at the conclusion of the month, with a new promotion barrel setup for the next commencing month. All entries will not be retained for any other promotion.
13. It is the responsibility of eligible members to position themselves within either Burleigh Leagues Club or Burleigh Sports Club where they can hear the public-address announcements.
14. Members must present their membership card to the promotion host when claiming a prize. Additional proof of identity may be requested at the discretion of management.
15. Members selected from the Nexus Draw application will have two (2) minutes to claim their prize from the specified draw area. If the selected winner does not present themselves to the promotion host within the two (2) minutes of being announced, they forfeit their claim to the prize and a redraw will take place until an eligible winner is found.
16. Burleigh Leagues Club will have three (3) draws per month.
17. Burleigh Sports Club will have three (3) draws per month.
18. The draws will be held at both Burleigh Sports Club & Burleigh Leagues Club on the last Thursday of the month.

20. Burleigh Leagues Club will have total of \$2,000 cash available to be won every calendar month.
21. Burleigh Sports Club will have a total of \$2,000 cash available to be won every calendar month.
