

LUCKY LOOT**Terms & Conditions**

1. The Lucky Loot promotion will commence at 10am on Thursday 11 June 2026 and run until approximately 10:00pm on Thursday 27 August 2026.
2. This promotion is open to all current financials members The Bears Group are eligible for the promotion.
3. Members will earn one (1) entry during the promotional period with every \$10 play (turnover) on the gaming machines with their membership card inserted at Burleigh Sports Club.
4. Members can enter as many times as they like during the promotional period when they meet entry criteria.
5. Management may elect to offer bonus cash prizes based on members loyalty tier, offer bonus entries into the promotion, &/or bonus entry periods for nominated draw dates at their discretion.
6. All promotions are conducted using the Nexus barrel system, no paper tickets will be issued.
7. Entries earned during each promotional week will remain valid until the conclusion of the Thursday promotional draw period for that week.
8. Following the final draw each Thursday night, all entries will be deleted and will not be retained for any future promotional draw dates.
9. Members must be present on the draw days and times to win.
10. Members selected from the electronic draw system have two (2) minutes to claim their prize from the specified draw area. If the selected winner does not present themselves to the promotion host within the two (2) minutes of being announced, they forfeit their claim to the prize and a redraw will occur until a winner is found.
11. It is the responsibility of eligible members to position themselves within Burleigh Sports Club where they can hear the public-address announcements.
12. Winners must present their membership card to the promotion host when claiming their prize. Additional proof of identity may be requested at the discretion of management.
13. Draws will be conducted every Thursday during the promotional period between approximately 8:00pm – 10:00pm.
14. A total of five (5) winners will be drawn each Thursday promotional draw night.
15. Each winner selected from the draw will participate in the Lucky Loot gameboard promotion for a guaranteed cash prize.
16. Members selected from the draw will select three (3) cards from Level One (1) of the gameboard.
17. If all three (3) cards reveal a **LUCKY** icon (“\$” symbol), member can take the chance to advance to the next level **or** keep the cash prize for that level.
18. If any card reveals a **non-LUCKY** symbol (“lemon”), member game ends and member receives **\$100 as base from Level 1.**
19. **Prize values are displayed on the gameboard per level and are not cumulative.**
 1. The Level cash prize breakdown is as follows:
 - a. Level 1 – \$100
 - b. Level 2 – \$150
 - c. Level 3 – \$200
 - d. Level 4 – \$300
 - e. Level 5 – \$500
20. All winners are guaranteed a minimum cash prize of \$100.
21. After each draw, all cards will be returned to the gameboard, shuffled and reset ahead of the next draw.

22. Members may win multiple times throughout each promotional draw day.
23. The total promotional prize pool is estimated at approximately \$7,600 across the sixteen (16) weeks promotional period.
