

MONEY RUSH**Terms & Conditions**

1. Burleigh Sports Club is conducting the MONEY RUSH promotion from Saturday 13 June 2026 to Saturday 26 September 2026 inclusive, unless extended or amended by management.
2. Entry is open to all financial members of The Bears Group are eligible for the promotion.
3. Entries may only be earned on Saturdays during the promotional period.
4. Entries can only be earned between 10:00am and 9:59pm each Saturday.
5. Members will receive one (1) entry into the virtual promotional barrel for every \$10 PLAY recorded on gaming machines while their membership card is correctly inserted.
