



DOUBLE THE MAJORS

TERMS AND CONDITIONS

General

1. The Double the Major promotion will commence on Tuesday 9 June 2026 and Promotion is conducted: Tuesday 10am – 12am and Wednesday night from 10pm – 2am until further notice.
2. All financial Burleigh Sports Club members are eligible for this promotion.
3. Members can enter by simply playing any machine during the promotional timeframe.
4. Members can enter/ PLAY as many times as they like during the promotional period when they meet the appropriate criteria.
5. The FIRST member each promotional night to win a 'Major' jackpot will win double their machine's jackpot prize. Once the winner has been announcement and credentials checked the promotion will be complete. It is the member's responsibility to notify gaming staff upon winning a 'major' jackpot during the promotional timeframe. Members can do this by pressing the call button on their gaming machine.
6. Members must have their membership card inserted into the gaming machine when a staff member or Duty Manager comes to confirm the jackpot win. Additional proof of identity may be requested at the discretion of management.
7. Varying EGMs use various names for their jackpots, including but not limited to 'Major', 'Super', 'Maxi', 'Mini', 'Minor', and/or 'Grand'. All jackpots not specifically named 'Major' are ineligible to be included in the promotion and will not be doubled if won.
8. There is no capped limit to the major jackpot prize won.
9. All promotions are conducted using the Nexus Promotion system, no paper tickets will be issued.
10. Winners must be present.
11. Members must be present in the club on the promotional days and times to claim a major prize.
