

CASH IN A FLASH**Terms & Conditions****GENERAL**

1. The 'Cash in a Flash' promotion will commence on Wednesday 5 August 2026 and run until Wednesday 28 October, with one (1) promotional draw day each week:
 - a. Every Wednesday Morning
2. All carded members playing on gaming machines at Burleigh Sports Club on Wednesdays during the promotion are eligible.
3. Members will be selected at random through Odyssey/Nexus to receive a cash prize.
4. Members selected have two (2) minutes to claim their prize from the specified draw area. If the selected winner does not present themselves to the promotion host within two (2) minutes of being announced, they forfeit their claim to the prize, and a redraw will be conducted to select another winner.
5. Members must be present on the draw day and time to win.
6. If a selected member does not claim their prize within two (2) minutes, another eligible member will be randomly selected through Odyssey/Nexus until a winner is present and claims the prize.
